RELEASE/WAIVER READ CAREFULLY BEFORE SIGNING

To All To Whom These Present Shall Come or May Concern Greetings:

In consideration and exchange for being permitted to leave my child in the care of DuPage AME Church and its Angel's Church, I agree to the following:

KNOW YE THAT THE UNDERSIGNED, does hereby REMISE, RELEASE AND FOREVER DISCHARGE DuPage AME Church, DuPage AMEC's Angel's Church and each and all of their respective agents, employee's, servants, volunteers and any other persons whomsoever are associated with and/or affiliated, in any way, with DuPage AME Church, DuPage AMEC's Angel's Church and their auxiliaries of and from any and all past, present and future actions, claims, demands, damages, third party actions, causes of action or suits at law or in equity for monies allegedly due and owing including claims for contribution and/or indemnity whatsoever which claimant now has or may hereafter have on account of or arising out of any event, incident, circumstance, occurrence or happening that results in any injuries, death, losses, damages, liabilities, or expenses that are caused or alleged to be caused by DuPage AME Church, DuPage AMEC's Angel's Church and each and all of their respective agents, employee's, servants, volunteers and any other persons whomsoever are associated with and/or affiliated, in any way, with DuPage AME Church, DuPage AMEC's Angel's Church and their auxiliaries negligent and willful and wanton acts or omissions, or the condition of the property, facilities or equipment used at DuPage AME Church during the time that I leave my child in the care with DuPage AME Church and its Angel's Church.

I hereby release, waive, discharge and agree not to sue or seek compensation of any kind, in any form, from DuPage AME Church and its Angel's Church or their Agents, Employees, Officers, Servants, Volunteers or any other persons whomsoever are associated with and/or affiliated, in any way, with DuPage AME Church, DuPage AMEC's Angel's Church and its/their auxiliaries for and from any injuries, death, losses, damages, liabilities, or expenses that are caused or alleged to be caused by DuPage AME Church and its Angel's Church or their Agents, Employees, Officers, Servants, Volunteers or any other persons whomsoever are associated with and/or affiliated, in any way, with DuPage AME Church, DuPage AMEC's Angel's Church and its/their auxiliaries negligent and willful and wanton acts or omissions and the condition of the property, facilities or equipment used during the time that I leave my child in the care with DuPage AME Church and its Angel's Church.

I assume full and complete responsibility for any and all injury, bodily injury, emotional injury, psychological injury, personal injury, or damage of any kind, sustained by my child which is or may be caused by the condition of any property, facilities, and/or equipment used by and/or in connection with DuPage AME Church and its Angel's Church while my child is in the care of DuPage AME Church and its Angel's Church.

I agree to indemnify, defend, and hold harmless DuPage AME Church and its Angel's Church or their Agents, Employees, Officers, Servants, Volunteers or any other persons whomsoever are associated with and/or affiliated, in any way, with DuPage AME Church, DuPage AMEC's Angel's Church and its/their auxiliaries from and against any claims, causes of action, damages, judgments, liabilities, fees (including attorney's fees), costs and expenses incurred by them as a result of their having to defend against any and all claims, demands, third party actions, causes of action or suits at law or in equity for monies including claims for contribution and/or indemnity.

As further consideration, the undersigned warrants that no promise or agreement not herein expressed has been made to the undersigned; that in executing this Release/Waiver the undersigned is not relying upon any statement or representation made by the party or parties hereby released or said party's or parties' agents, employees, officers, servants or volunteers but is relying solely upon her/his own judgment and knowledge; that undersigned is over eighteen years of age and legally competent to execute this Release; and that before signing and sealing this Release, undersigned has fully informed him/her self of its contents and meaning and has executed it with full knowledge thereof.

This waiver and release is a legally binding agreement and will be construed broadly to provide a waiver and release to the maximum extent permissible under applicable law. Any provisions found to be void or unenforceable shall be severed from this agreement, and not affect the validity or enforceability of any other provisions. **I HAVE READ THIS DOCUMENT AND I UNDERSTAND ITS CONTENT. I UNDERSTAND THAT BY SIGNING BELOW, I HAVE GIVEN UP SUBSTANTIAL RIGHTS. I HAVE VOLUNTARILY SIGNED THIS RELEASE. I AGREE THIS DOCUMENT IS NOT ONLY BINDING ON ME BUT WILL ALSO BE BINDING UPON MY PERSONAL REPRESENTATIVES, EXECUTORS, HEIRS AND NEXT OF KIN.**
